3. Eligibility Criteria

- **Nationality:** the candidate should have Indian residency.
- **Age:** Application of customer services agent (CSA) must have attained the age of 18 years as on 1st July 2025 and the maximum age should be 27 years.
- **Character:** The candidate must have a character certificate showing that there is no criminal record against the candidate in the past as well as in present.
- **Education Qualification:** Candidate must have passed intermediate (10+2) or equivalent from the recognised board or university.
- **Physical Fitness:** No person shall be selected unless he/she is in good mental and physical health and free from any physical defect likely to interfere with the efficient performance on his/her official duties. Hence, person with benchmark disability (PwBD) shall not be eligible for customer service associate.

I. Details of syllabus:

a) **General Intelligence & Reasoning:** Analogies, Completion of Number and Alphabetical Series, Coding and Decoding, Mathematical Operations, Similarities and Differences, Relationships, Analytical Reasoning, Syllogism, Jumbling, Venn Diagrams, Puzzle, Data Sufficiency, Statement-Conclusion, Statement-Courses of Action, Decision Making, Maps, Interpretation of Graphs etc.

b) **Numeric Aptitude:** The paper will include questions on problems relating to number system, computation whole numbers, decimals and fractions and relationship between numbers, fundamental arithmetical operations, percentages, ratio and proportion, averages, interest, profit and distance, ratio and time, time and work etc.

c) **General English:** candidates understanding of English language and its correct usage, vocabulary, grammar, sentences structure, synonyms, antonyms and its correct usage etc.

d) **General Awareness:** Questions will be designed to test the ability of the candidate's general awareness of the environment around them and it's applications to society. Questions will also be designed to test knowledge of current events and of such matters of everyday observation and experience in their scientific aspects as may be expected out of educated personnel. The test will also include questions relating to India and its neighbouring countries especially pertaining to sports, history, culture, geography, economic scene, general policy including Indian constitutions and scientific research etc. These questions will be such that they do not require a special study of any discipline.

II. The paper will consist of objective type-multiple choice questions only. The questions will be sent both in English and hindi, except general English, English language & comprehension.

III. There will be no negative marking.

IV. Minimum qualifying marks for the examination is 35 %.

V. **Difficulty level of question paper:** The difficulty level of questions related to academic subjects will be of Secondary Senior Secondary level as prescribed by the National Council of Educational and Research (NCERT).

VI. **Medium of examination:** The paper will be in bilingual i.e., Hindi and English. In case of any ambiguity between Hindi and English version due to transaction. English version would be treated as final.

7. Dress-Code for Examination

The candidates are instructed to follow the following dress code while appearing for NIA Exam

- Light clothes with half sleeves not having big buttons, brooch/badge, flower etc. with Salwar/ Trousers.

8. Mode of Selection For Training

- Written test (multiple choice question based objective type)
- Interview

9. Minimum Qualifying Standard

The minimum qualifying standard shall be :

- 35 % marks in written test (multiple choice question).
- Candidate must have passed interview after passing the examination.

10. Selection Procedure Of Training

1. The date of examination indicated in the advertisement is purely tentative in nature. Any change in the schedule of examination shall be brought to the notice of candidates only through the official website of the NIA Aviation Services Pvt. Ltd. No personal communication shall be made in this regard.
2. The NIA Aviation Services Pvt. Ltd. reserves the right to bring about changes in the selection procedure/ scheme of examination.
